## **HEALTH REGULATION ORDINANCE 2016**

### **HEALTH REGULATION AUTHORITY (AMENDMENT) (NO. 2) REGULATIONS 2024**

*(Legal Notice 72 of 2024)*

**MADE** by the Minister under section 51 of the Health Regulation Ordinance.

#### **Citation and commencement**

1. These Regulations may be cited as the Health Regulation Authority (Amendment) (No. 2) Regulations 2024 and shall come into operation on the same day as the Health Regulation (Amendment) Ordinance 2024.

#### **Interpretation**

2. In these Regulations “principal Regulations” means the Health Regulation Authority Regulations.

#### **Regulation 5 amended**

3. Regulation 5(2) of the principal Regulations is amended by inserting the following after paragraph (d)—

“(e) the scope of health services to be provided by the licensee in the facility.”.

#### **Regulation 28 amended**

4. Section 28(1) of the principal Regulations is amended by deleting the words “registered and licensed health professional” and substituting “licensed registered practitioner”.

#### **Regulation 58 amended**

5. Section 58(2) of the principal Regulations is amended by deleting the words “registered practitioner” and substituting “licensed registered practitioner”.

#### **Schedule 1 amended**

6. Schedule 1 to the principal Regulations is amended—

- (a) in Form 1, in the part for Attestation under paragraph 3, by deleting the words “registered practitioner” and substituting “licensed registered practitioner”; and
- (b) by deleting Form 3 and substituting—

## **EXPLANATORY NOTE**

*(This Note is not part of the Regulations)*

These Regulations seek to amend the Health Regulation Authority Regulations—

- (a)* to substitute “registered practitioner” to “licensed registered practitioner”, to ensure that it is clear that the health professional in the amended regulations should be both registered and licensed;
- (b)* to make it clearer that health services should be listed on a health care facility licence, and replace the licence in the Regulations with a part where health services can be listed on the licence.
